WHEREAS, the recognition was granted to the institution namely Sri Murugha Rajendra Swamiji B.Ed College, Saraswathipur, Kusnoor Road, Gulbarga-585105, Karnataka run by Reshmi Vividdodesh Sangh, Gulbarga, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/APSO2185/B.Ed/2004-2005/8924 dt. 30.11.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 30.01.2015 for its willingness for adherence of provisions of new Regulations. A provisional revised recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. AND WHEREAS, the institution submitted reply to the revised order on 29.06.2015 & 31.10.215. SRC in its 314<sup>th</sup> meeting held during 27<sup>th</sup> to 28<sup>th</sup> May, 2016 considered the matter of institutions which have been given recognition for offering with an intake of 100 students and directed RD, SRO to initiate VT inspection.

4. AND WHEREAS, as per the decision of SRC, an inspection letter was issued to the institution on 22.06.2016. Accordingly, inspection was conducted on 08.10.2016 to 09.10.2016 and the VT report along with documents was received on 12.10.2016. The SRC in its  $341^{st}$  meeting held during  $15^{th} - 16^{th}$  June, 2017 considered the VT Report and decided as under:-

- 1. Title is not clear. Application was from Rashmi Vividdodesh Sangh but the land document is in favour of Rashmi Educational & Charitable Trust. They should explain this. Land area is adequate.
- 2. LUC is in order except for a discrepancy in the area. Land document shows it as 50,985 Sq ft whereas LUC shows it as 57, 085 Sq ft.
- 3. EC is in order. In favour of Rashmi Educational & Charitable Trust.
- 4. BP is not approved by Comp. authority shows built up area as 57, 095 Sqft (5300 Sq mts).
- 5. BCC is not in original, only a photocopy. Not approved by Comp. authority. Builtup area shown is 1,37, 800 Sqft. This violates the limit of 57095 Sq ft permitted by the BP. It also shows a large tinshed. Regulations also not allow temp. structures.
- 6. FDRs are required in original in Joint account with a 5-year validity @ 7 + 5 lakhs per programme. They should submit accordingly.

7. They will need 1+15 Faculty for B.Ed (2 units) and 1 + 10 for M.Ed. The Faculty lists submitted have the following deficiencies:

- (i) They are in format. They have 1 + 15 and 1 + 10 But, every page is not authenticated by the Registrar.
- (ii) They are only a photocopy. Originals are required.
- (iii) The Composition of subject groups is in order.
- (iv) The Principal is common for both B.Ed & M.Ed.
- 8. Built up area required for B.Ed (2 Units), M.Ed (1 Unit) and D.El.Ed (1 Unit) is 3500 Sq mt (for D.El.Ed + B.Ed + M.Ed combo) + 500 Sq mt = 4000 Sq mt. whereas what they have is 12402 Sq mt (acc to BCC) and 5138 Sq mt (acc to BP) Although, they have enough under both situations, the major discrepancy between BP and BCC has to be first rectified. They should also clearly indicate the earmarking of area Programmewise.
- 9. Issue SCN accordingly. Send a copy for inf to the Univ.
- 10. Put up in Aug. 17

5. **AND WHEREAS**, as per the decision of SRC a show cause notice was issued to the institution on 06.07.2017. The institution is submitted a show cause notice reply on 01.08.2017. The SRC in its 346th meeting held during 24th to 25th October, 2017 considered the matter and decided to as under:-

- 1. Land documents are in order.
- 2. LUC is in order.
- 3. EC is not clear. 'Search Period' gives only one date, possibly, the issue date. Also, all sy nos given in the land documents are not covered.
- 4. BP is in order. Shows a built up area of 8472 sq mts which is quite adequate.
- 5. BCC is in order. Built up area of 8472 is adequate for D.El.Ed (1 unit), B.Ed (2 units) and M.Ed (1 unit).
- 6.1 FDRs for B.Ed & M.Ed are in order.
- 6.2 FDRs for D.El.Ed are not given.
- 7. Faculty list is in order.
- 8. Issue SCN for EC and FDR for D.EI.Ed.

6. AND WHEREAS, a show cause notice was issued to the institution on 01.11.2017. The institution vide letter dated 29.11.2017 submitted reply of its show cause notice. The SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause to the institution on 29.11.2019. The institution vide letter dated 10.12.2019 submitted its reply to Final Show Cause Notice. The SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> to 09<sup>th</sup> January, 2020 considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records submitted by the institution on 10.12.2019 in respect of Final Show Cause Notice. The Committee decided that the continuation order be issued to Sri Murugha Rajendraswamiji college, Karnataka for B.Ed programme for 2 units (50 students each unit).

7. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Murugha Rajendraswamiji B.Ed College, Sy No. 32/2, Plot No. 140/1 & 140/2, Gram Panchayat, Kusnoor, Tq & District Gulbarga-585105, Karnataka run by Reshmi Educational & Charitable Trust Gulbaraga Karnataka for continuation of recognition for B.Ed course of two years duration with an intake of (Two unit) of 50 students each subject to fulfillment of the following conditions:

- 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10.   k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
